ID	Violations resulting in 1 penalty point	Comments
A1	Illegal driving on Airside	
A2	Driving a vehicle that has not undergone daily self-inspection	
A3	Driving a vehicle that is prohibited for use	Vehicles with an expired vehicle permit are automatically prohibited for use.
A4	Driving a vehicle in the movement area without the correct warning lights	
A5	Driving a vehicle that does not meet the visibility requirements stipulated in AR	
A6	Driving a vehicle within the ERA area with aircraft taxiing in and out & the anti-collision light is illuminated or docking system is on.	Does not apply to follow-me, pushback vehicles, etc.
A7	Driving a vehicle between aircraft & refuelling vehicles that are in position	In position means ready for refuelling
A8	Driving a vehicle in a way that obstructs a vehicle about to leave the manoeuvring area	
A9	Driving a vehicle with more baggage/container trolleys connected than allowed by AR	
A10	Driving a vehicle with passengers not seated in the designated place.	
A11	Driver violates the Sterile driver environment	
A12	Driver/passenger not using the seat belt while the vehicle is moving	Applies only to vehicles with seat belts and not to emergency vehicles
A13	Parking the vehicle in an undesignated area	
A14	Violations of traffic signs/road markings or rules of the road	Does not apply to stop or one-way signs
A15	Careless driving level 1	The driver has deliberately driven the vehicle in a careless manner

ID	Violations resulting in 2 penalty points	Comments
B1	Illegal driving in special areas, excluding the manoeuvring area.	
B2	Illegal driving in the Manoeuvring Area	Assessed as RWI/TWI and/or without clear disruption to air traffic
В3	The driver does not meet the conditions for a driving licence	If necessary, add codes for conditions Conditions and medical requirements – Swedish Transport Agency
B4	Unnecessary escorting in the movement area with LVP	
B5	Driving a vehicle in a way that impedes access for emergency services during an emergency response	
B6	Driving a vehicle and breaking up a vehicle escort	
B7	Driving a vehicle without giving way to aircraft during take-off, landing, taxiing, towing or push-back without adversely affecting the aircraft.	
B8	Driving a vehicle between aircraft & marshals/docking system when taxiing in	
В9	Driving the wrong way on a one-way route	
B10	Failing to stop at a stop sign/red light	Also applies to red traffic lights
B11	Blocking the evacuation route of refuelling vehicles during refuelling	
B12	Vehicle parked in an undesignated area that impedes access for emergency services or operational activities	
B13	Negligent driving level 2	The driver has deliberately driven the vehicle in a negligent manner with a negative impact on the operational environment.

ID	Violations resulting in revocation of driving permit	Comments
C1	Illegal driving in the Manoeuvring Area (RWI & TWI)	Assessed as RWI/TWI and/or with clear disruption to air traffic
C2	Unnecessarily driving in the manoeuvring area with LVP	
C3	Driving a vehicle in a negligent manner that obstructs the emergency services during an emergency response	
C4	Driving a vehicle in a negligent manner that obstructs snow removal vehicles during assignments/training	
C5	Driving a vehicle between aircraft and Follow Me vehicles during ongoing assignments	
C6	Driving a vehicle without giving way to moving aircraft and the aircraft was adversely affected.	
C7	Vehicle parked in an undesignated area that obstructs access for emergency services or operational activities	
C8	Driving a vehicle in the manoeuvring area without valid authorisation	
C9	Grossly illegal driving on Airside	Driving a vehicle while your driving licence is revoked
C10	Grossly Negligent driving level 3	The driver has deliberately driven the vehicle in a grossly negligent manner with a major negative impact on the operational environment.

• If the police find that you are under the influence of drugs or drink-driving, your driving permit will be revoked.

ID	Speeding violations (km/h)	1 point	2 points	Revocation of driving permit
D1	Level 1 Pedestrian areas ≤8km/h	N/A	≥3 km/h above the permitted speed	≥8 km/h above the permitted speed
D2	Level 2 Speeds above level 1 up to ≤20 km/h	≥3 km/h above the permitted speed	≥10 km/h above the permitted speed	≥15 km/h above the permitted speed
D3	Level 3 Speeds above level 2 up to and including ≤30 km/h	≥5 km/h above the permitted speed	≥10 km/h above the permitted speed	≥20 km/h above the permitted speed
D4	Level 4 Speeds above level 3 up to and including ≤50 km/h	≥5 km/h above the permitted speed	≥10 km/h above the permitted speed	≥20 km/h above the permitted speed

Lack of authorisation documents

ID	Driving without authorisation documents	Warning	1 point	2 points	Revocation of driving permit
E1	The driver is unable to show a driving licence/driving permit	If the driving licence/driving permit is in their locker, the person must retrieve and show this immediately.	When checked	≥2 occasions within 6 months	≥3 points within 24 months
E2	Driving a vehicle without a valid vehicle permit	N/A	When checked	≥2 occasions within 6 months	≥3 points within 24 months

Revocation of vehicle permit

ID	Categories	Warning + Prohibition of use	Revocation of vehicle permit
F1	The vehicle does not comply with the Airport Regulation	When checked/audited	On the second warning for the same violation
F2	The vehicle lacks maintenance documentation	When checked/audited	On the second warning for the same violation
F3	The vehicle has not undergone an inspection/roadworthiness test in accordance with national regulations.	When checked/audited	On the second warning for the same violation
F4	The vehicle is driven despite being prohibited for use	When checked (NB! Exceptions are allowed for transportation to a workshop if Swedavia is notified in advance)	On the second warning for the same violation
F5	Vehicle is parked incorrectly on airside with no driver.	When checked	On the second warning for the same violation
